

Denise McClure-This is not a large addition. It makes sense that they are asking for a waiver for traffic. Final elevations should be submitted for approval.

Janet Morris-I just want to make sure that if we grant a waiver, Con Com can still ask for whatever they need.

Denise McClure-By you granting that waiver, doesn't mean that you are granting the waiver for Con Com.

Jim Dangora Jr.-For clarification the NOI has not been filed yet, it will be shortly.

Blake Robertson-I did go and walk the area today and I was a little surprised that they cut the pavement.

Mike Cavanaugh-The work you saw today was part of Boston Materials TI project, which is a different permit all together. That what for a propane line that is going to their space. It has nothing to do with this project

Blake Robertson-Are you going to finish the interior renovation before adding the addition?

Mike Cavanaugh-Yes

Blake Robertson-What is your intent of when this is going to begin.

Mike Cavanaugh-As soon as we get approval hopefully by the end of June

Blake Robertson-The note here says it is going to be two stories. And tell me about the parking?

Jim Dangora Jr-It will be a single-story high bay.

Tim Williams-We are re-striping the parking for ADA

Ed Giroux-It is nice to get a building occupied that has been empty. Will something be going in the other build on MTP.

Jim Dangora Jr.- My understanding that the outfit that bought it is going to occupy it.

Ed Giroux-That is great news and I support this.

Michael Parker-All of my questions have been answered. I walked the site today and I am happy that this building will be filled.

Marlies Henderson-Michael Parker and I have picked up a refrigerator from there. I was illegally dumped. There is a gate there that looks trampled. I think it would be great to keep that gate opened, maybe repaired? Put a rock there because the property has been used as a dumping site. Can you put an outdoor cigarette receptacle for smokers? The proposed path is marked on the plan.

Jim Dangora Jr-No problem for the cigarette receptacle. As far as the bike path, I can't commit Rhino to an easement. I just respectfully request that you don't nail them down because it could have some impact. We are happy to comply with DPW request of showing it on the plan.

Marlies Henderson-I will talk to you offline

Jim Dangora Jr.-By committing these folks to an easement at this point could have ramifications. There is a good deal of work that could be done.

Denise McClure-The bike path on the plan. A reference that it is there.

Janet Morris-I hope Boston Materials understand that the bike path is something near and dear to the Town. I really want the property owners to know that to.

Michael Parker-We are approving this, we don't want to stop this tenant's ability to get approval because of this bike path. They have already been part of this conversation.
