THE UNDERSIGNED APPLICANT BEING FAMILIAR WITH THE REQUIREMENTS OF THE TOWN OF BILLERICA DPW DOES HEREBY AGREE TO ADHERE TO THE TOWN OF BILLERICA TRASH AND RECYCLING REGULATIONS:

- ~ Recycling is mandatory in the Town of Billerica. Only approved recyclables (paper, cardboard, bottles, cans, jars and jugs) may be placed into recycle cart. **Recyclables must not be placed into plastic bags.**
- ~ Trash carts are for residential household refuse, and shall not contain "waste ban" items such as recyclable material (cardboard, paper, bottles, jars, cans, etc.), construction debris, yard waste, hazardous materials, white goods or appliances such as TV's, computer monitors, air conditioners, tires, large metal items, etc.
- ~ For Additional Trash Carts: Total Fees of \$185 are required for the first year, and a collection fee (currently \$120 per year) will be billed by the Town annually thereafter, due by June 15 every year.
- ~ For Additional Recycle Carts: Total Fees of \$155 are required for the first year, and a collection fee (currently \$90 per year) will be billed by the Town annually thereafter, due by June 15 every year.
- ~ALL Carts remain the property of the Town of Billerica. Original cart is assigned to the residence and shall not be moved. Additional carts must be returned to the Town when no longer needed by the resident. If resident moves within Billerica, the additional carts may be returned or registered at the new address. Resident must notify Town of the new address. Carts found at wrong address will be removed.
- ~Payable in 2 checks: One check for (one time) Cart Fee to WASTE MANAGEMENT, and one check for Collection Fee to TOWN OF BILLERICA. Payment covers service year from July 1 to June 30.
